

MINUTES of the Annual General Meeting of the Board of Directors of the McGill University Health Centre (MUHC) held at 5100 Boulevard de Maisonneuve, the main floor conference room in Montreal, Quebec on Wednesday, December 3, 2013 at 16:00 hrs.

1. **Chairman's Opening Remarks - C. Bussandri**

On behalf of the Board of Directors, C. Bussandri welcomed the public.

C. Bussandri noted that the current Board is half way through it's four year mandate. He also noted that the next two years will present many challenges because of the move to the Glen.

C. Bussandri mentioned that Board members and staff had received a rating score of 93% in the latest Canada Accreditation report. This rating score was based on a performance evaluation of 3000 criteria.

C. Bussandri also reported that major changes had been made with respect to the organizational structure of the Board committees.

In terms of the financial status of the organization, C. Bussandri informed the public that last year's deficit was \$72.5 million dollars but that the forecasted deficit for the next fiscal year was \$20 million dollars.
